MEETINGS VIA TELECONFERENCING

RECOMMENDED ACTION

Adopt Joint Resolution 22-42 making certain findings that the existence of a local and state of emergency in California exists, that social distancing being mandated or recommended by state or local officials due to the ongoing COVID-19 pandemic and that meeting in person presents an imminent risk to the health and safety of attendees.

BACKGROUND

Introduced by Assemblymember Robert Rivas (D-Hollister) on February 1, 2021, AB 361 codifies portions of Governor Gavin Newsom's prior order suspending certain teleconferencing requirements under the Ralph M. Brown Act. It permits a local agency to continue to teleconference with fewer limitations if a local agency makes specified findings, and upon making such findings for the first time, makes the findings every 30 days thereafter. Specifically, the AB 361 exempts a local agency from Brown Act requirements to post agendas and make accessible to the public every location from which a member of a Brown Act body teleconferences. The legislation expires in December 2024. On September 16, 2021, California Governor Gavin Newsom signed AB 361 into law, effective immediately.

A local agency wishing to rely on the provisions of AB 361 must meet one of the following criteria:

- 1. The local agency holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
- 2. The local agency holds a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California due to the threat of COVID-19 and shortly thereafter issued Executive Order N-29-20 suspending certain Brown Act provisions relating to teleconferencing as public meetings began to be held online.¹

¹ Similarly, on March 4, 2020, the Los Angeles County Board of Supervisors and Los Angeles County Health Officer declared a local and health emergency due to the threat of COVID-19.



However, this Executive Order expired on September 30, 2021, despite the State of Emergency remaining in place.

The threat that COVID-19 has presented continues to directly impact the ability of the SGVCOG to conduct Governing Board/committee meetings safely in person. The Centers for Disease Control and Los Angeles Department of Public Health (LADPH) continue to advise governmental entities to refrain from conducting indoor meetings and consider moving operations outdoors, where feasible, to prevent transmission. Additionally, LADPH continues to recommend social distancing measures throughout Los Angeles County in all settings.

In order to continue to conduct meetings in a safe manner and to prevent unnecessary COVID-19 exposure to members, staff and the public, staff is recommending that the Capital Projects and Construction Committee, Executive Committee, Governing Board, and Transportation Committee adopt a resolution making certain findings in order to be able to continue teleconferencing for its meetings.

This resolution will be considered at a joint meeting of the Capital Projects and Construction Committee, Executive Committee, Governing Board, and Transportation Committee. For those Governing Board delegates who are on the Board and one or more Committees, when roll call is taken and your name called, your vote will be counted toward both the Governing Board count and the Committee(s) upon which you are a member. If you desire to register a different vote for the Board and the Committee upon which you are a member, please indicate the vote for the Governing Board and for the Committee at the time your name is called. Otherwise, a single "yes" or "no" vote will be counted as a "yes" or "no" vote for both the Governing Board and the Committee(s) upon which you are a member.

RE: REVISIONS TO THE SGVCOG MEASURE M MULTI-YEAR

SUBREGIONAL PROGRAM (MSP) PUBLIC OUTREACH PLAN

RECOMMENDED ACTION

Adopt Resolution 22-43 to revise the SGVCOG Measure M Subregional Program (MSP) Public Outreach Plan.

BACKGROUND

Measure M, which was a ½ cent sales tax measure to provide funding for transportation improvements across Los Angeles County, was approved by voters in November 2016. In 2018, the Los Angeles County Metropolitan Transportation Authority (Metro) adopted the Measure M Guidelines to establish a process by which subregional funds under Measure M would be programmed by the subregions' respective entities. The SGVCOG was subsequently tasked with programming and administering the MSP funds.

As a result of the passage of Measure M, the SGVCOG adopted Resolution 18-11 in 2018 to create a Public Outreach Plan (Attachment A) for all MSP funding award, reallocation, and program requests. The Plan satisfies the Measure M Guidelines by ensuring that the key stakeholders' inputs are solicited whenever key decisions about the MSP's administrative processes and funding awards are made.

Over the past four years, the SGVCOG diligently followed the Public Outreach Plan as the agency recommended Metro to award more than \$52 million in MSP funds to 21 active transportation, first/last mile, bus system improvements, and highway efficiency projects.

In May 2022, the SGVCOG Governing Board adopted Resolution 22-25 (Attachment B) to revise the structures of the SGVCOG Public Works TAC and the SGVCOG Planning Directors' TAC. As replacement of these established TACs, working groups in each of these areas would be formed on an as needed basis. As a result of this change, staff proposes to revise the MSP Public Outreach Plan as follows (changes are bolded):

- 1. Staff will develop a preliminary proposed project list for each sub-fund based on cash flow and results for the adopted Mobility Matrix.
- 2. This list will be distributed to COG member agencies and other stakeholders and posted on the COG's website for comment. Staff will attempt to make personal contact with known stakeholders and offer briefings if desired.
- 3. The proposed project list, as well as any comments received, will be **shared with the Public Works Working Group and the Planning Directors' Working Group,** and the City Managers' Steering Committee, for discussion and public input.



- 4. Inputs and recommendations from the Public Works Working Group, Planning Directors' Working Group, and the City Managers' Steering Committee will be forwarded to the COG's Transportation Committee and agendized for discussion and public input.
- 5. Final recommendations from the COG's Transportation Committee will be forwarded to the COG's Governing Board for final approval.
- 6. Upon approval of the MSP 5-Year Plan by the Metro Board and subsequent execution of funding MOU's with each individual project implementing agency, further outreach regarding the design, environmental clearance and construction of those projects will be handled individually by the implementing agency in accordance with funding guidelines and local policies.

These proposed changes were previously presented to the Transportation Committee, City Managers' Steering Committee, Public Works Working Group, and Planning Directors' Working Group for review and approval. All four entities subsequently approved the changes.

RECOMMENDED ACTION

Recommend Claremont City Councilmember Jennifer Stark to serve as a SGVCOG Delegate on the San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy Board of Directors.

BACKGROUND

The San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy (RMC) was established in 1999 to preserve open space and habitat in order to provide for low-impact recreation and educational uses, wildlife habitat restoration and protection, and watershed improvements within its jurisdiction. The RMC covers a vast area that includes mountains, valleys, rivers, coastal plains, and coastlines in eastern Los Angeles County and western Orange County. A map of RMC's jurisdiction can be found in Attachment A.

The RMC Board of Directors, known as the RMC Governing Board, is comprised of 15 voting members and 9 non-voting members who are appointed or designated by virtue of the local, state, or federal offices they hold. The Conservancy has no power of condemnation or authority over local zoning laws. The Board holds its regular meetings on the third Monday of January, March, May, June, July, September, and November at 1:30pm.

The composition of the Board is specified by California Public Resources Code Section 32605, which designates that three voting members of the Board are recommended and/or appointed by the SGVCOG:

- 1. One SGVCOG Governing Board member who serves as a mayor or city councilmember of a city bordering the San Gabriel River and its tributaries, appointed by the SGVCOG;
- 2. One SGVCOG Governing Board member who serves as a mayor or city councilmember of a city bordering the San Gabriel Mountains, appointed by the California Senate Rules Committee at the recommendation of the SGVCOG; and
- 3. One resident from a city bordering the San Gabriel River, appointed by the Office of the Governor at the recommendation of the SGVCOG. ¹

¹ On April 21, 2016, the SGVCOG Governing Board voted to limit the nominations of this seat to mayors and councilmembers from eligible cities. The SGVCOG must submit two eligible nominees to the Office of Governor for consideration.



Seat #2 is currently open for re-appointment due to San Dimas City Councilmember Denis Bertone's recent departure from the San Dimas City Council. The nominee must be a mayor or a city councilmember from cities bordering the San Gabriel Mountains within the RMC's jurisdiction. These cities include Arcadia, Azusa, Claremont, Duarte, Glendora, La Verne, Monrovia, Pasadena, San Dimas, and Sierra Madre.

The SGVCOG Energy, Environment, and Natural Resources (EENR) Committee convened in June 2022 and voted to recommend the Governing Board to recommend Claremont City Councilmember Jennifer Stark to serve as the replacement delegate on the RMC Board of Directors.

RE: SB 991 (NEWMAN) – PUBLIC CONTRACTS: PROGRESSIVE DESIGN-

BUILD: LOCAL AGENCIES

RECOMMENDED ACTION

Adopt Resolution 22-44 supporting SB 991 (Newman).

BACKGROUND

Cities, counties, and special districts that are authorized to provide for the production, storage, supply, treatment, or distribution of any water from any source are currently limited to the Design-Bid-Build method of procurement for public works projects. A public works project is described by the state to mean the construction, alteration, demolition, installation, or repair work done under contract and paid for in whole or in part out of public funds, except work done directly by a public utility company pursuant to order of the Public Utilities Commission or other public authority. Currently, public works projects are only authorized to use the design-bid-build method, in which a public agency fully completes the design of a project prior to awarding a construction contract and must award the contract to the "lowest responsible bidder." This process is intended to ensure that the project is built for the lowest possible cost. This bill would authorize such local agencies to use the progressive design-build process for public works projects in excess of \$5,000,000, until January 1, 2029. The bill defines progressive design-build procurement method to mean a project delivery process in which both the design and construction of a project are procured from a single entity that is selected through a qualifications-based selection at the earliest feasible stage of the project.

The bill would require a local agency that uses the progressive design-build process to submit, no later than January 1, 2028, to the appropriate policy and fiscal committees of the Legislature, a report on the use of the progressive design-build process containing specified information, including a description of the projects awarded using the progressive design-build process.

DISCUSSION

The traditional design-bid-build procurement method, in which the lowest bidder is selected, can create challenges in completing complicated projects. Using lowest bidder for highly complicated projects can sometimes lead local agencies to sacrifices in quality or significant change orders. In addition, the design-bid-build procurement method requires a different firm for design and construction, and there can be inconsistencies between the two firms, leading to additional costs and delays. According to the bill's author and other proponents, SB 991 will afford local water agencies the option of using the progressive design-build contracting method to reduce overall project risks, costs, and schedules for public works projects estimated to cost more than \$5 million. The design-build procurement method attempts to solve the problem of two firms having inconsistent approaches, but it doesn't provide the collaborative progressive approach that progressive design-build advocates claim can improve outcomes. Since local agencies in

California have limited experience with progressive design-build, there is some additional risk to using this new procurement method. To mitigate the risk, this bill provides an "off ramp" to local agencies that are unable to agree to a guaranteed maximum price with the progressive design-build entity they selected and solicit proposals from other firms to complete the work. Additionally, the bill includes reporting language that will inform the Legislature how local agencies use this authority in time to make changes before it sunsets in 2029.

SB 991 has passed the Senate Governance & Finance and Appropriations Committees and Senate Floor on unanimous votes and is in the Assembly awaiting referral to committee. Supporters of the bill include—but are not limited to—the following:

At the Water Policy Committee/WG meeting on June 14, 2022, the Water Policy Committee unanimously approved recommending the Governing Board support SB 991 (Newman).

RE: HOMELESS PROGRAMS TO ADDRESS FOOD INSECURITY

RECOMMENDED ACTION

Allocate \$250,000 to support food insecurity programs for persons experiencing homelessness or at-risk of homelessness.

BACKGROUND

In 2019, the SGVCOG received a State budget earmark of \$5.625 million for the implementation of programs that supported persons experiencing homelessness (PEH). The majority of that funding - \$3.3 million — was allocated directly to cities to implement their previously-adopted homelessness plans. Cities developed and implemented their own projects, based on their own adopted priorities. Some additional funding went to service providers to provide services for PEH. While each city and service providers had different programs to serve PEH, there were several consistent priorities that emerged in the implementation of these different programs. One of these priorities was funding for food for PEH and for those at-risk of homelessness.

Since these programs ended in June 2022, the SGVCOG has continued to talk to cities, service providers, and nonprofit organizations, and all have continued to identify food as a critical need for their agencies. Service providers operating shelters provide three meals per day for their residents, which represents a significant cost for program operation. Unsheltered residents – or even those living in housing thanks to a housing voucher – still suffer from food insecurity, and service providers and cities want to continue to provide food and food options for these residents. However, limited budgets and significantly increasing costs have made it difficult to meet the level of need, especially over the last year.

Amongst all San Gabriel Valley residents, food insecurity is a major concern. A study by the Los Angeles County Department of Public Health (DPH) conducted in 2018 found that approximately 66,000 residents in the San Gabriel Valley faced food insecurity, and approximately 21,000 residents in the San Gabriel Valley had very low food security, meaning that they had had multiple indications of disrupted eating patterns and reduced food intake. The pandemic exacerbated food instability, with 34% of households in Los Angeles across all income levels facing food insecurity. Food pantries continue to distribute significantly more food than they had before the

pandemic.

While food insecurity has been increasing, there has also been a growing focus on reducing food waste. Passed in 2016, SB 1383 (Lara) set methane emissions reduction targets for California, including a requirement to reduce organic waste disposal 75% by 2025 and rescue at least 20% of currently disposed surplus food for people to eat by 2025. Specifically, as part of the implementation of SB 1383, large commercial food generating organizations (large grocery stores, supermarkets, wholesale food vendors, and food service providers) must donate edible food to food recovery organizations (such as food pantries and food banks), beginning in January of 2022. Beginning in January 2024, additional types of businesses – including health facilities, large hotels and vendors, large restaurants, and large agencies with on-site food facilities – will also be required to donate edible food. These large entities are required to establish contracts with food recovery organizations to formalize these donations. Local jurisdictions are responsible for educating commercial edible food generators, increasing food generator access to food recovery organizations, monitoring food generator compliance, and increasing food recovery capacity if there isn't sufficient capacity to meet edible food recovery needs.

To assist cities with compliance, the SGVCOG has worked with 14 member cities and its consultant – SCS Engineers – to complete an initial evaluation to identify food recovery organizations and their capacity to accept edible food, to calculate the estimated amount of edible food generated by the impacted commercial edible food generators, and to develop and implement an outreach and education plan for participating cities. As part of this initial evaluation, the SGVCOG's consultant found that less than one-third of these large generators were currently donating food. The consultant found that, at present, there was a recovery capacity of between 15 and 17 million pounds in the 14 participating cities, and there was edible food generation of approximately 15 million pounds. However, it is anticipated that the amount of edible food generated will increase, meaning that there will need to be additional recovery capacity. Phase 2 of this Program involves the establishment of regional food recovery hubs, which would help to increase the recovery capacity here in the region.

These parallel efforts and priorities at the SGVCOG create a unique opportunity to assist cities in their compliance with food recovery requirements while also addressing the extreme unmet need for food here in the San Gabriel Valley. Several jurisdictions have already implemented programs to this effect. In the County of Los Angeles, the County Department of Public Health implemented the Nutrition and Physical Activity Program, in which they coordinated with Los Angeles Regional Food Bank and several food rescue and community-based organizations to collect more than 12 million pounds of food and distribute it to individuals accessing services at schools, healthcare settings, and parks. In San Francisco, the City's "Kitchen Zero SF" program recovered more than 3.2 million pounds of edible food from June 2019 – March 2022 through SB 1383 compliance activities and, working with nonprofits and food pantries, redistributed this food to residents in need.

Due to cities and service providers' challenges in expending previous funds, the SGVCOG currently has approximately \$550,000 in unallocated funds which can be used for activities that support PEH or those at-risk of homelessness. SGVCOG staff is recommending that a portion of these funds - \$250,000 – be allocated to support a program to address food insecurity for PEH or those at-risk of homelessness, with a specific focus on building the capacity of food recovery



organizations and partners to be prepared for the expected increase in donated food in the coming year. SGVCOG staff is recommending the implementation of a grant program for local jurisdictions, non-profits, and service providers, for activities that would increase the infrastructure and capacity of these local agencies to collect and distribute food to PEH and those at-risk of homelessness. This work can additionally be supported by additional funding, which cities have received from the California Department of Resources Recycling and Recovery (CalRecycle) and which they have allocated to the SGVCOG to support the regional implementation of these programs. These funds can be used for the purchase of equipment (e.g., freezers, storage, etc.), transport of food, and costs associated with the set-up of the program. There is some initial work that must be done before the CalRecycle funds can be expended, and this proposed program could support this effort.

DISCUSSION

As discussed above, staff recommends that the SGVCOG implement a grant program for cities, nonprofits, and service providers to apply for funding to establish and/or increase their capacity to collect food and distribute food to PEH or those at-risk of homelessness. The grant program would target entities and opportunities that would help support the expansion of food recovery capacity as the implementation of SB 1383 advances. The program would allow for eligible entities to apply for funding to support immediate needs, such as the purchase of food to cover existing gaps, but the focus of the grant program would be on establishing and expanding the capacity and infrastructure necessary to accept the increased expected amount of food donations as more businesses comply with their food recovery requirements. This program would serve as a bridge as SGVCOG staff moves forward with the implementation of the CalRecycle grant program. The intent of the program is to provide flexibility in the eligible activities, to allow applicants to craft proposals that would best allow them to meet the program goals.

Given the short funding deadlines and the immediate needs, staff is working as quickly as possible to advance this effort.

NEXT STEPS

At its August 3, 2022, meeting, the Homelessness Committee approved a motion to recommend Governing Board allocate \$250,000 to support food insecurity programs for persons experiencing homelessness or at-risk of homelessness. As such, if this action is approved by the Governing Board, SGVCOG staff would develop an application process for eligible applicants. Should demand exceed availability of funds, SGVCOG would evaluate the applications in line with the program's priorities of reducing food insecurity for PEH and those at-risk of homelessness and demonstrating how the application would lead to increased food recovery capacity. Attachment A provides the Food Insecurity Grant Program Application. Individual grants awards would be under the Executive Director's contract approval authority, so, if these actions are approved, no further action would be required.

RE: AUTHORIZATION TO EXECUTE AGREEMENTS IMPLEMENTING

THE SAN GABRIEL VALLEY WILDFIRE ADAPTATION AND PREVENTION OUTREACH PROGRAM AND THE SAN GABRIEL VALLEY REGIONAL COMMUNITY WILDFIRE PROTECTION PLAN

RECOMMENDED ACTION

1) Authorize the Executive Director to execute an agreement or an amendment with the Department of Forestry and Fire Protection (CalFIRE) to receive an amount not-to-exceed \$250,468.50 in FY 2022-2023 for the implementation of the San Gabriel Valley Wildfire Adaptation and Prevention Outreach Program.

2) Authorize the Executive Director to execute an agreement or an amendment with the The Department of Forestry and Fire Protection (CalFIRE) to receive an amount not-to-exceed \$677,959.00 in FY 2022-2023 for the implementation of the San Gabriel Valley Regional Community Wildfire Protection Plan.

BACKGROUND

In a survey conducted by the SGVCOG following the Bobcat Fire, cities expressed support for the development of a Regional Wildfire Adaptation Plan. Additionally, cities shared that they are interested in joining a regional effort to provide evacuation planning, structure hardening, hazardous fuel reduction, brush mitigation, and community education support.

To support these efforts, the SGVCOG applied for and was awarded \$250,468.50 in funding from the California Climate Investment Fire Prevention Grant Program to implement the San Gabriel Valley Wildfire Adaptation and Outreach Program. This program aims to provide support to San Gabriel Valley cities to conduct community outreach efforts. Activities would include wildfire prevention workshops, training sessions, community events, presentations, yard audit assessments, and digital outreach efforts. With this funding, SGVCOG staff can disseminate information and resources to cities' residents, businesses, local community organizations, and schools through various channels.

Additionally, the SGVCOG was awarded \$667,959.00 in funding from the California Climate Investment Fire Prevention Grant Program to develop the San Gabriel Valley Regional Community Wildfire Protection Plan (CWPP). This plan can serve as the foundational strategic document that would guide the wildfire adaptation and prevention efforts of the 31 incorporated cities and the dozens of unincorporated communities within the San Gabriel Valley. The process of developing a Community Wildfire Protection Plan greatly supports the region to clarify and refine its priorities for the protection of life, property, and critical infrastructure in the San Gabriel Valley's wildland-urban interface. The development of a CWPP can also lead community members, including elected officials, city staff, community organizations, and residents, through



valuable discussions regarding management options and implications for the region's surrounding watersheds.

Staff recommends the Governing Board authorize the Executive Director to execute an agreement with the Department of Forestry and Fire Protection (CalFIRE) to receive an amount not-to-exceed \$250,468.50 for the San Gabriel Valley Wildfire Adaptation and Outreach program, and an amount not-to-exceed \$667,959.00 for the San Gabriel Valley Regional Community Wildfire Protection Plan

RE: SUPPORT AB 2622 (MULLIN): SALES AND USE TAXES EXEMPTION

FOR ZERO EMISSION TRANSIT BUSES

RECOMMENDED ACTION

Adopt Resolution 22-45 in support of AB 2622.

BACKGROUND

Current sales and use tax laws in California include exemptions for the sale, storage, and use of zero-emission transit buses. The exemptions are limited to those buses that were sold to public agencies who are eligible for the California Hybrid and Zero-Emission Truck and Bus Voucher Incentive Project under the State Air Resources Board. They are meant to relieve some of the financial burden on municipalities that would like to invest (or have already invested) in electric or hydrogen fuel cell electric bus fleets. It is anticipated that the tax exemption will allow public transit agencies to save between \$30,000 and \$50,000 on each zero-emission bus purchased. The current regulation governing this exemption expires on January 1, 2024.

AB 2622 (Mullin) would extend this exemption by two years to January 1, 2026. The extension is timely because it will to allow agencies to have clarity on which taxes will apply as they plan their capital budgets – procurement processes for these fleets typically begin 18-24 months before purchase. The bill also includes a provision requiring the Legislative Analyst's Office to report to the Legislature on the effectiveness of the tax exemption by May 1, 2024.

At this time there are no significant opposition to the bill.

SGVCOG POSITION

Staff recommends that the Governing Board adopt Resolution 22-45 in support of AB 2622. By



signaling our strong support for this legislation, the SGVCOG will continue to advocate for the best interests of its member agencies and residents. Support for the bill aligns with the San Gabriel Valleys consistent leadership record on issues related to greenhouse gas emissions, air quality, and responsible tax incentive structures. The SGVCOG Transportation Committee is scheduled to consider recommending that the Governing Board support AB 2622 at its next regular meeting on August 11, 2022.

The bill passed unanimously through the Senate Governance and Finance Committee and is expected to advance to a Senate vote in August.

REGIONAL HOUSING TRUST UPDATE

In 2021 the San Gabriel Valley Regional Housing Trust developed a tiny homes bridge housing pilot program and partnered with the Cities of Baldwin Park and Montebello to deliver 55 units of temporary homeless housing. The 25-unit project in the City of Baldwin Park, Esperanza Villa, was the first tiny home bridge housing site in the San Gabriel Valley and opened in November 2021. Operation Stay Safe, the 30-unit tiny home site in Montebello, opened in July 2022. Both sites are operated by Volunteers of America Los Angeles (VOALA). VOALA works with clients to establish a housing and finance plan to increase their income and create a pathway to permanent housing.

Esperanza Villa has served as a valuable resource to the community since its opening. The site is a City owned lot which was directly adjacent to an area identified as a hotspot in the 2020 homeless count. The count noted over 500 individuals experiencing homelessness in the City. Since opening, calls for service in the area have decreased. Six clients have been permanently housed and additional clients have been connected with housing vouchers and are currently seeking permanent housing. The SGVRHT and SGVCOG are working with VOALA and additional Coordinated Entry System (CES) providers to help streamline the transition to permanent housing.

Esperanza Villa accepts referrals from SPA 3 partners including Union Station, VOALA, Baldwin Park PD, and LAHSA. Operation Stay Safe referrals are centralized through direct outreach by the Montebello Community Assistance Program (MCAP). Both sites have a local preference for individuals experiencing homeless in the community and maintain a waitlist to seamlessly move clients in as units are turned over.

The City of Baldwin Park is developing a second tiny home site for families which will open September 24, 2022. To learn more about each of these sites please visit: www.sgvrht.org/tinyhomes

RE: GOSGV REGIONAL BIKESHARE PROGRAM UPDATE

RECOMMENDED ACTION

BACKGROUND

In August 2017, the San Gabriel Valley Council of Governments (SGVCOG) received \$4.554 million in Greenhouse Gas Reduction Fund-Active Transportation Program (GGRF-ATP) funds from the California Transportation Commission to launch a regional e-bike share program in the San Gabriel Valley. The program was to deploy 840 e-bikes in 15 participating jurisdictions, with at least 420 e-bikes serving disadvantaged communities (DACs). The program was to be a dockless program so that users could return the e-bikes to any existing bike rack of identified bike parking location. Eligible expenditures for the funding including infrastructure (e.g. e-bikes; stations) and program start-up costs. Operations could not be covered under the grant funding. The funding was to be expended by December 17, 2021. The program has faced challenges over the years, and SGVCOG worked with local organizations and community stakeholders to reimagine the program.

COVID-RELATED CHALLENGES

In early 2019, the SGVCOG completed a competitive procurement process. At its February 2019 meeting, the Capital Projects and Construction Committee (CPCC) authorized the Chief Engineer to execute an Agreement with Gotcha Media Holdings, LLC to operate the program. Staff prepared to launch the program in March 2020, but unfortunately, this corresponded with the start of the COVID-19 pandemic. The COVID-19 pandemic upended the shared mobility industry, as people were told to stay-at-home and people were fearful of shared devices. Some programs shut down – either temporarily or permanently – and, while some programs experienced initial upticks in ridership, it did ultimately fall. Despite this, the SGVCOG was able to launch its initial programs in the summer of 2020. However, like most bike share programs nationwide, ridership remained low, and it was difficult for operators to cover their true operational costs. Many programs halted operations. Gotcha was not immune to these challenges and, unfortunately, as reported to the CPCC, in January 2021, the SGVCOG was notified that Gotcha ended up dissolving its operations for all of its programs across the country – including the program in the San Gabriel Valley.

In spring 2021, SGVCOG staff convened discussions with regional stakeholders, including local non-profits and participating cities, to discuss how the program could be re-launched. While Gotcha's GoSGV program did end after approximately six months of program operation, SGVCOG staff was able to take this opportunity to re-imagine the program to serve the San Gabriel Valley even more effectively. The work completed – including the station siting and the community engagement done in coordination with ActiveSGV as part of the program roll-out – provided a strong foundation and valuable tools to reconsider the Program.

SGVCOG staff determined that a better approach to e-bike share in the San Gabriel Valley was to focus on longer-term bike "check-outs," at station locations that were primarily located off of the public right-of-way. The intent was for local businesses and community partners to serve as the station locations where users could check-out e-bikes. The additional program intent was to specifically target those users who would be the most likely to use an e-bike to replace existing drive-alone trips, thus maximizing the vehicle miles traveled (VMT) reduction of the program. These targeted users included students at colleges and universities, employees at large businesses and campus environments (including business parks), and other community members who may be inclined to try an e-bike for active transportation but may not have the money to purchase it. E-bikes typically cost several thousand dollars, and there can be many other additional barriers – including technical expertise – to initial access. For a monthly cost, users would be able to "checkout" an e-bike for an extended period of time and, during that time, have exclusive access to that e-bike as their own. This program design would not only maximize the VMT impact of the program but also minimize the staffing costs associated with operating the program, as bike rebalancing would be a much smaller component of the Program.

GOSGV PROGRAM IMPLEMENTATION

E-Bikes

In September 2021, staff released a request for quotes (RFQ) for the purchase of 840 e-bikes, including traditional e-bikes and cargo e-bikes. At its October 2021 meeting, the CPCC authorized the Executive Director to execute purchase orders (POs) for the purchase of e-bikes with the selected vendors.

- B-Cycle: purchase of 828 e-bikes;
- Pedal Movement, LLC: purchase of 12 cargo e-bikes.

SGVCOG staff executed these POs in late 2021, and the e-bikes and cargo e-bikes were made available to the SGVCOG. The success in being able to purchase bikes and have them delivered within the grant funding timelines is particularly notable because there continues to be worldwide shortages of e-bikes and massive supply-chain issues.

Program Operator

To support program operations, in October 2021, the SGVCOG released a request for proposals (RFP) to select an operator for this modified program. The RFP established the following general scope of work for the operator:

- Manage/administer program that provides longer-term check-out periods for users, including processes, procedures, practices, and schedules for e-bike deployment, customer usage/check-out, customer service, pricing, marketing, and data management to support program viability;
- Manage receipt and inventory of up to 840 e-bikes;
- Provide ongoing, regular maintenance and repair to ensure the e-bikes are in safe and good working condition;
- Provide intuitive, user-friendly, and accessible reservation and registration processes for users;
- Provide customizable user-fee structure that ensures system sustainability;
- Coordinate with SGVCOG and e-bike vendor to accept and manage customer payments;
- Incorporate strategies to minimize e-bike loss that could occur through the non-return of e-bikes, theft, or other mechanisms;
- Incorporate partnerships with local entities (e.g. nonprofits, colleges/universities, local businesses) to support program roll-out and implementation;
- Deploy at least 50% of e-bikes to serve disadvantaged communities;
- Be financially self-sustaining through rider fees, sponsorships, and/or other private funding mechanisms.

The grant does not fund operations; thus, the operator would not receive any funding from the SGVCOG to operate this program. The program was to be entirely self-sustaining through rider fees and sponsorships, although the SGVCOG would also actively look for other additional funding sources – including grants and sponsorships – that could support the operation of the program in the future.



Upon technical review of the proposals, the TEC recommended ActiveSGV - a local non-profit that supports the expansion of bike ridership and other forms of active transportation in the San Gabriel Valley - as the program operator.

GOSGV LAUNCH

Over the past several months, SGVCOG has been working with ActiveSGV to structure the transformed GoSGV bike share program. As discussed above, San Gabriel Valley residents can check out an e-bike for monthly use. For the duration of their check-out period, the participant will have exclusive use of that e-bike as their own for their daily use. Participants can sign up for the program and pick-up an e-bike from various program partners across the region – rather than on the public right-of-way – or, for an additional cost, have the e-bike delivered to their home. ActiveSGV is working with local bike shops, who will provide maintenance for the e-bikes. The SGVCOG and ActiveSGV are also working with several colleges to implement more locally-based programs on their campuses. The program is also looking to incorporate other program partners – including cities, nonprofit organizations, and businesses – that may benefit from program participation. Governing Board members who have recommendations for potential partners that might be interested in program participation are encouraged to reach-out to SGVCOG staff.

The new GoSGV program is intended to re-launch for a beta roll-out in late June or early July 2022, with a public roll-out later in the summer.

At the June Governing Board meeting, staff provided a written update on the program's challenges and program status. At this month's meeting, ActiveSGV's Education Director Jose Jimenez will provide an overview of the program and the status of program roll-out.
