At a special meeting, the public may only comment on items that are on the agenda. Members of the public are requested to state their name prior to speaking, and comments are limited to a maximum of three minutes per person. The Committee Chair may impose additional time limits if comments become repetitious, an individual member of the public seeks to speak on numerous items, or a large number of members of the public seek to speak on an item. The Committee may not take action on items not on the agenda and is restricted in discussing items on the agenda.

\*MEETING MODIFICATIONS DUE TO THE STATE AND LOCAL EMERGENCY RESULTING FROM THE THREAT OF COVID-19: AB 361 (Rivas), signed by California Governor Gavin Newsom on September 16, 2021, authorizes local agencies to hold public meetings via teleconferencing and allows for members of the public to observe and address the meeting telephonically or electronically to promote social distancing due to the state and local emergency resulting from the threat of the Novel Coronavirus (COVID-19).

## **RECOMMENDED ACTION**

Adopt Resolution 22-12-EENR making certain findings that the existence of a local and state of emergency in California caused by the ongoing COVID-19 pandemic continues to directly impact the ability of the SGVCOG to hold public meetings safely in-person, thereby necessitating an ability to continue holding meetings via teleconferencing.

### **BACKGROUND**

Introduced by Assemblymember Robert Rivas (D-Hollister) on February 1, 2021, AB 361 codifies portions of Governor Gavin Newsom's existing Ralph M. Brown Act exemptions pertaining to teleconferencing if a local agency issues an emergency finding, and reissues it every 30 days, that it is unsafe to meet in person. Specifically, the Brown Act exemptions include requirements to provide a public teleconference location, to maintain a member quorum within the agency's jurisdiction and to provide for public comment at each teleconference location, such as a private residence. The legislation expires in December 2024. On September 16, 2021, California Governor Gavin Newsom signed AB 361 into law, effective immediately.

A local agency wishing to rely on the provisions of AB 361 must meet one of the following criteria:

- 1. The local agency holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
- 2. The local holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or
- 3. The local agency holds a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California due to the threat of COVID-19 and shortly thereafter issued Executive Order N-29-20 suspending certain Brown Act provisions relating to teleconferencing as public meetings began to be held online.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> Similarly, on March 4, 2020, the Los Angeles County Board of Supervisors and Los Angeles County Health Officer declared a local and health emergency due to the threat of COVID-19.



However, this Executive Order expired on September 30, 2021, despite the State of Emergency remaining in place.

The threat that COVID-19 has presented continues to directly impact the ability of the SGVCOG to conduct Governing Board/committee meetings safely in person. Updated guidelines issued by the Centers for Disease Control and Prevention (CDC) and the Los Angeles County Department of Public Health in July and August 2021 advise governmental entities to refrain from conducting indoor meetings and consider moving operations outdoors, where feasible, to prevent transmission. SGVCOG staff finds it has been unable to find a suitable outdoor space with the requisite audio/visual capabilities at which the monthly committee meetings can be held safely. Similarly, an indoor space with sufficient capacity to accommodate safe social distance practices among members, staff, and the public could not be identified.

In order to continue to conduct meetings in a safe manner and to prevent unnecessary COVID-19 exposure to members, staff and the public, staff is recommending that the EENR Committee adopts a resolution making certain findings in order to be able to continue teleconferencing for its meetings.

## **RECOMMENDED ACTION**

### **BACKGROUND**

On August 28, 2022, the San Gabriel Valley based nonprofit Nature for All received a \$995,000 grant from U.S. Representative Judy Chu to begin planning and building the Mount Wilson Express Shuttle, a van or bus service starting from the Metro L (Gold) Line Memorial Park Station in Old Pasadena and connecting to various location in the Angeles National Forest. The Angeles National Forest has been accessible only be car for the last 130 years, since the Mount Lowe Railway shut down in 1936.

Early planning for the Mount Wilson Express Shuttle suggests a potential regular, weekend shuttle that will take passengers up to Angeles National Forest with stops at the Mt. Wilson Observatory, Haramokngna American Indian Culture Center at Red Box, Clear Creek Information Center, and trailheads at Eaton Saddle, Colby Canyon, and Gould Mesa.

The San Gabriel Mountains, the mountain range protected by the Angeles National Forest, make up 70% of Los Angeles County's open space. Currently, the Forest and Mountains can only be reached by private vehicle, creating concerns regarding outdoor accessibility and equity.

Representative Judy Chu also placed a request for an additional \$750,000 in the 2023 House of Representatives appropriations bill to support shuttle operation and maintenance.

At this EENR Committee meeting, Bryan Matsumoto from Nature for All will provide a planning update on the Mount Wilson Express Shuttle as well as share a brief overview of Nature for All's related programming.

RE: EQUITABLE COMMUNITY REVITALIZATION GRANT

## **RECOMMENDED ACTION**

### **BACKGROUND**

In 2021, Governor Gavin Newsom signed Cleanup In Vulnerable Communities Initiative (CVCI) legislation, allocating \$500 million to expedite the cleanup and beneficial reuse of contaminated properties. Through this initiative, priority is given to properties in historically vulnerable and disadvantaged communities. The Department of Toxic Substances Control's Office of Brownfields Equitable Community Revitalization Grant (ECRG) will provide more than \$250 million in grants to incentivize cleanup and investment in disadvantaged areas of California.

The program gives California communities an opportunity to address harmful brownfield sites and set a new path for land use that will have immediate and lasting benefits, such as recreational uses, commercial enterprises and housing. ECRG funding is available to help California public entities, nonprofit organizations and Tribes to conduct:

- Community-wide assessments
- Environmental investigations
- Environmental cleanups

The first round of the ECRG closed April 2022 and awardees were announced June 2022. The next round of the ECRG will begin late 2022 to early 2023. Round 2 of the ECRG will issue grants ranging from \$80,000 to \$7 million for environmentally-impacted sites ranging from preliminary environmental assessments to clean-up.
