RE: SGV REGIONAL BIKE SHARE EXPANSION

RECOMMENDED ACTION

Discuss and provide direction to staff.

BACKGROUND:

On August 16, the California Transportation Commission awarded the SGVCOG \$4.5 million to expand bike share throughout the San Gabriel Valley (SGV). The grant will fund 840 bicycles at 84 bike stations in 15-member cities¹, including:

- Baldwin Park
- Claremont
- Covina
- Duarte
- El Monte
- Glendora
- La Canada Flintridge
- La Verne
- Monrovia
- Monterey Park
- Pomona
- San Dimas
- South El Monte
- South Pasadena
- West Covina

Stations will be sited near transit stations, employment centers, colleges, and downtowns.

Bike share will offer an opportunity for students, commuters, and all residents to easily try and use bicycling as a mode of transportation and to assist SGV cities to further activate their bicycle infrastructure network. The proposed bike share expansion will be a catalyst to increase bicycle and transit ridership by providing convenient access to bicycles for short trips and for the first and last mile around light/commuter rail and other high use transit stations. Under the terms of the grant, over half of the bike stations will be located within disadvantaged communities. Disadvantaged residents will receive subsidized access and information on the benefits and opportunities provided by using bike share. This mode shift away from private automobile is a key

part of plans to reduce greenhouse gas (GHG) emissions and traffic, and improve air quality, as well as mobility, health and safety.

There are two primary issues that staff is currently working on:

- **Development of a Regional-Scale Network:** Staff is working with Metro staff to undertake a regional approach to completing the feasibility study and developing the most effective multi-city regional bikeshare network. This is a new approach for Metro, as they typically work on a city-by-city basis to develop bikeshare networks. Staff will use the results this study to guide the placement of the 84 stations/840 bikes. Potentially, staff may recommend the placement of additional stations, which would require securing additional funding, to create a robust and effective network. Staff is seeking affirmation of this approach from the Transportation Committee.
- Operations & Maintenance Funding: The grant fund covers only costs associated with capital and program launch. Staff is pursuing a number of options to cover the full O&M costs during an initial pilot period and to lower long-term O&M costs for cities. Potential funding sources include Measure M, AQMD, and sponsorships.

Staff hosted a workshop for city staff on October 11th, and Metro staff will provide an update at October Transportation Committee.


