#### PRESENTATIONS

6. Foothill Gold Line Phase 2B First/Last Mile Plan

Katie Lemmon, who is the Senior Manager of Transportation Planning for First/Last Mile at LA Metro, provided a presentation on this item to the Committee. Ms. Lemmon touched upon the first/last mile methodology and process, walk audits, context-specific recommendations, coordination and community engagement, including with ActiveSGV, example FLM project types, possible pathway networks, and next steps for the plan's adoption and eventual implementation.

Questions/Discussion:

- Mr. Fasana mentioned that with Measure M, cities must contribute 3% and FLM investments can count towards that 3%.
- Ms. Lemmon highlighted that this is the final plan but will have small corrections in the upcoming weeks.
- 8. LA Metro NextGen Bus Study: Draft Service and Route Concepts Presentation by

Robert Cálix, Senior Manager of Transportation Planning in the Communications Division at LA Metro, along with Wayne Wassell, Transportation Planning Manager at LA Metro, provided a presentation on this item to the Committee. They touched on the current status and progress of the NextGen Bus Study which is a qualitative and quantitative analysis of Metro's existing bus system, and the NextGen Bus Study process will eventually yield a bus system redesign and re-allocation of bus service, based on analyses, to better serve the ever changing needs and demands of LA County and its diverse residents and communities. During the presentation, Mr. Cálix and Mr. Wassell discussed how NextGen will address and incorporate equity, the vast amount of community engagement that Metro has conducted to get feedback from riders and community members, and what factors Metro studied in its bus network development process. Metro finished its presentation by sharing examples of service design concepts, and the timeline for the duration of the rest of the study. Metro plans to return to the Transportation Committee in October 2019 to share new draft "lines on the map," or new draft bus routes. Moreover, the Committee heard updates pertaining to LA Metro and the Foothill Gold Line extension.

**Questions/Discussion**:

- Through the study, Metro is reallocating service hours. There may be a plethora of trade offs involved in devising the draft service concepts, new routes, and a new network.
- Metro will be doing an analysis of every single bus line.
- A Committee Member brought up that many people in the SGV take line 47 and the park and ride lot of this line is usually full by 6 AM. There was a request to make sure that this line will still go to Downtown Los Angeles.
- The Committee requested analytical data of the area which the NextGen Bus used for their maps.
- Mr. Fasana mentioned that whenever bus service is cut, it impacts people and how prepared is Metro to address issues that are created due to reallocation and shifting bus schedules and routes.

#### **RE:** GOTCHA SAN GABRIEL VALLEY BIKE SHARE

#### **RECOMMENDED ACTION**

#### BACKGROUND

In August 2017, the San Gabriel Valley Council of Governments (SGVCOG) was awarded funding by the California Transportation Commission (CTC)'s Greenhouse Gas Reduction Fund Grant Program in the amount of \$4.55 million to form a regional pilot bike share program in the San Gabriel Grant Program in the amount of \$4.55 million to form a regional pilot bike share program in the San Gabriel Valley. The SGVCOG's goals for the Program are to decrease drive alone trips and increase the share of bicycling trips within the San Gabriel Valley, promote and encourage bicycling as a safe and sustainable mode of transportation for short local trips, including one-way trips, and expand lowcost transportation options in the region. This funding will support the implementation of a regional e-bike share program, deploying a minimum of 840 bikes in at least 15 participating cities. The program will be available to cities at no cost. Following a competitive procurement and technical evaluation process completed by COG and City staff, Gotcha Media Holdings was selected to deploy the 840 e-bikes throughout the region. Gotcha also offers scooters, trikes and ride share services.

COG staff is currently working with the Gotcha team and participating cities to implement the regional pilot program. Key tasks that are underway are as follows:

- **Development of template ordinance**: This template can be used by cities to establish the shared mobility pilot program within their city. It will provide the framework and establish parameters for the pilot bike share program.
- **Refinement of station types**: COG staff is working with participating cities to review and select the appropriate bike station types. Issues under consideration include virtual hubs (geofenced) vs. physical stations; mats/designated return zones vs. bike racks; and branded vs. universal bike racks.
- **Station siting**: Cities are evaluating potential station sites in conjunction with the Gotcha team, identifying locations that would offer the most convenient location for residents to acquire a bike in high traffic areas such as universities, large employers, and shopping/dining hubs.

Along with the above steps, staff is also working with cities to select appropriate events to launch the bikes. At this time, the COG intends to launch the regional e-bike share program in conjunction with the 626 Golden Streets: Streets and Treats Open Streets event to be held in El Monte and South El Monte on October 26, 2019. The overall timeless is as follows:

- July 2019: Template ordinance completed
- October 2019: 626 Golden Streets & Treats (El Monte, South El Monte)
- February 2020: Last chance for cities to participate

- April 2020: 626 Golden Streets: Heart of the Foothills (Pomona, San Dimas, La Verne)
- June 2020: All bikes deployed


