BACKGROUND


The Pomona Hope for Home Services Center is a year-round interim housing site that provides access and navigation services for individuals facing homelessness that are seeking permanent housing solutions. Hope for Home pursues a mission of restoring hope through creating opportunity and transforming the lives of individuals who desire to break free from the cycle of homelessness. The organization strives to help participants overcome their barriers in order to obtain permanent housing, increase their income, improve their health, and achieve independence.

The center is a 15,000 square-foot access facility that offers in-take services and a clinic for mental and behavioral health services. The facility also includes restrooms, lockers, kennels, laundry rooms, a medical clinic, an open office for city or police officials, and a guest desk for agencies that are not site partners to provide services on-site.

City of Pomona Neighborhood Services Director, Benita DeFrank, will provide a tour of the Hope for Home Services Center for the committee.
