

Mr. Reutimann also pointed out that bikers, when they are surveyed, want protected bike lanes in order to improve their safety.

Additionally, Andrew Ross, a Civil Engineer with LA County Public Works, addressed some of Mr. Reutimann's concerns, and also provided more details about LA County's proposed Huntington Drive bike lanes project.

J. Dever, the District Manager of the San Gabriel Valley Mosquito and Vector Control District, provided the presentation on this item to the Governing Board. - Chief Engineer's Monthly Report Paul Hubler presented the recent election results specific to the San Gabriel Valley's legislative delegation and the projects assigned to the Committee.

Mr. Christoffels announced the departure of the ACE Contracts Manager and that due to the sudden position vacancy, an interim Contracts Manager has been obtained until the position is permanently filled. He indicated that a contract for the interim position will be brought to the Committee in December for approval.

Mr. Christoffels announced that the Durfee Avenue construction bids were received and the lowest bidder was 24% over the **engineer's** estimate, which may require us to reevaluate the remaining projects and adjust anticipated expenditures for potential increases. He indicated that the price of labor and commodities increasing could be the reason for such high bids. He reported that a contract award would be brought to the Committee in December.

- 8. <u>Project Construction Progress Reports</u> Mr. Christoffels reported on the project updates at Fairway Drive and Fullerton Road. He indicated that the Brea Canyon on and off ramps at the 60 Interstate freeway are currently being removed after the completion of construction of the Lemon Avenue ramps for the Fairway Drive grade separation project. He showed the progress of the Fullerton Road paving of the roadway and the recent relocation of a large storm drain.
- 9. <u>Approval of Close out of Construction Contract with OHL USA, Inc. and</u> <u>Acceptance of the Puente Avenue Grade Separation as Substantially</u> <u>Complete</u> – Mr. Christoffels reported that the Puente Avenue grade separation project has been substantially completed. He indicated that the SBE goal of 11% was met, that the project employed 644 workers, 53 of which were local, 40 subcontractors were used, two of which were from the San Gabriel Valley. He asked for a motion to approve the closeout of the construction contract.

A motion was made by member Solis and seconded by member Sandoval to approve the closeout of construction contract with OHL USA, Inc. and accept the Puente Avenue grade separation project as substantially complete.

10. <u>Approval of Contract Close Out of Contract with Walsh Construction</u> <u>Company and Acceptance of the San Gabriel Trench Project as</u> <u>Substantially Complete</u> – Mr. Christoffels indicated that the San Gabriel Trench project had a change order percentage of -1% which is a very good outcome. He asked for a motion to approve the acceptance of the San Gabriel Trench as substantially complete and to close out the contract with Walsh Construction.

A motion was made by member Sandoval and seconded by member Lyons to approve the contract closeout with Walsh Construction Company and accept the San Gabriel Trench project as substantially complete.

Chairperson Costanzo announced that now that the San Gabriel Trench project is officially complete, her position as member and Chair has been fulfilled. She stated that she is honored to have served first as Vice Chair then as Chair over the past several years and she is passing the gavel over to our Vice Chair Victoria Martinez to assume the position as Chair.

Mr. Christoffels announced that the bylaws written for Board members are to stay on the Committee until the project in their city is complete, however the SGVCOG Governing Board recently voted member Costanzo to stay on our Committee as an alternate and therefore will still be involved in our projects.

The new Chairperson Martinez led the remainder of the meeting. She indicated that elections for the seat of Vice Chair will be held at the December meeting.

11. <u>Approval of Amendment No. 2 with Rowland Water District for the Fullerton Road Grade Separation Project</u> – Mr. Christoffels reported that the Board previously approved an agreement with Rowland Water District for water line relocation work at Fullerton Road. He indicated that additional lines were discovered after the work began that require relocating. He reported that the original contract amount was for \$2,225,898 and the additional expenditures are expected to be \$329,373.

A motion was made to authorize the Chief Engineer to execute an amended agreement with Rowland Water District for the Fullerton Road grade separation project for a revised amount of \$2,555,271.

12. <u>Receive and File Agreement No. 18-01 with CWE for Preliminary</u> <u>Engineering and Final Design Services for the Load Reduction Strategy</u> <u>Projects for the Rio Hondo River and Tributaries</u> – Mr. Christoffels announced that the agency will be bringing all executed contracts to the Committee to receive and file. He indicated this is a final agreement with the California Watershed Engineering Corporation (CWE) for preliminary design services for the Load Reduction Strategy Projects for the Rio Hondo River and Tributaries.

No action was required.

- **13.** <u>Outgoing Committee Member Recognition</u> Chairperson Martinez recognized the outgoing members for their participation and service to the Capital Projects and Construction Committee and to the ACE Board. The Committee presented plaques to members Sam Pedroza, Barbara Messina, and Juli Costanzo.
- 14. <u>Adjourn</u> The meeting adjourned at 12:36pm in honor of Patricia Wallach former SGVCOG member and ACE Board member and long-time member of the El Monte City Council. The next meeting will be held on December 17th.

BACKGROUND

In prior years, the ACE Board of Directors participated in an annual advocacy trip to Washington DC every March. This trip was scheduled to coincide with the APTA conference. Representatives from the SGVCOG, usually the President and/or First Vice-President, typically would also attend. During this trip, ACE representatives would meet with San Gabriel Valley representatives and other key decisionmakers. Building and maintaining strong relationships with the San Gabriel Valley's federal representatives has been critical to success of the ACE Project.

With the integration of the ACE and SGVCOG, this trip is being restructured to reflect the broader mission of the organization. Attendees will include the SGVCOG President and the chairs of each of the policy committees (i.e. Capital Projects & Construction, Transportation, EENR, Water and Homelessness). Staff will be working on informational materials that reflect the work of each of the committees as well as the overall goals of the agency. Additionally, over the past two years, severe winter weather, including blizzards and heavy snow, has negatively impacted the trip, including cancellation of meetings and closure of the Capitol. For that reason, the trip has been rescheduled for May 7-10. Staff will prepare a report out after the trip.

ACE also co-hosted a reception for our federal representatives during the annual advocacy trip. One challenge with that approach was that only the SGVCOG and ACE Board members attending the DC advocacy trip were able to participate. For that reason, this year staff will focus efforts on supporting local events, such as the annual SGV Legislative Reception that is co-hosted by the SGV Economic Partnership, to allow for broader participation of our member agencies.

In terms of broader context, the upcoming strategic planning workshop will provide an opportunity to discuss the SGVCOG's overall strategy related to federal and state advocacy.

The following are items of note since the last meeting:

<u>Durfee Contract Awarded</u> – The Committee in December authorized award of a contract to the lowest responsive bidder, Riverside Construction Company, in the amount of \$43.9 million for construction of the Durfee Avenue project in the City of the Pico Rivera. The contractor will construct a roadway underpass and modifications, railroad bridge, pump station, utility relocations and modifications and install landscaping and irrigation. Work will commence this Spring and be completed in three years.

<u>Committee Leadership</u> – The Committee voted unanimously in December to affirm El Monte Councilmember Victoria Martinez Muela as its Chair and Pomona Mayor Tim Sandoval as its Vice Chair. We are honored to be selected to serve in these leadership positions, and look forward to working with our colleagues and staff on completing the capital projects assigned to the Committee.

<u>TCIF Recycling</u> – Staff attended the California Transportation Commission meeting on December 5 and provided a joint agency letter advocating for project savings from the Proposition 1B Trade Corridor Improvement Fund to be recycled on future projects. The CTC is expected to take this item up at their March 2019 meeting. If approved, up to \$20 million in anticipated construction savings from the San Gabriel Trench and Puente Avenue projects in the closeout phase could be used on future ACE projects.

<u>Community Outreach Update</u> – Staff conducted the following project outreach activities:

DECEMBER MEETING RECAP

On December 5th, 2018, the Energy, Environment, and Natural Resources (EENR) Committee convened its December meeting at the Alameda Corridor-East (ACE) Construction Project's office in Irwindale, CA. There were two presentations at this meeting.

SB 212: Pharmaceutical and Sharps Take-Back Program – The first primary item on the agenda was a presentation by SGVCOG staff Alexander Fung. The presentation covered the background of SB 212 and the resulting impact of the bill. SB 212 is a state bill that requires manufacturers of pharmaceutical drugs and medical needles to establish, implement, and fund take-back programs for safe and secure collection and disposal of their products. This bill is the first statewide measure in the nation to include both prescription medications and medical needles. The bill applies to manufacturers of sharps, pet medications, prescribed medications, and over-the-counter (OTC) medications. While the SB 212 regulations are not enacted until 2021, cities can act now to raise awareness within their own communities. Local governments can partner with pharmacies, pharmaceutical companies, fire and police departments, and local clinics to host "takeback days" at least once a year. Typically, residents can drop off their unused or outdated medications and sharps at their local fire or police stations, clinics, and city halls on "take back days." Additionally, "National Take Back Day" is hosted by the U.S. Drug Enforcement Administration (DEA) every year.

National Park Trust's "Kids to Parks Day" – SGVCOG staff Alexander Fung provided the second presentation of the meeting. This presentation sought to a brief overview of National Park Trust's "Kids to Parks Day." Launched in 2011, Kids to Parks Day is a nationwide celebration of outdoor parks organized by the National Park Trust. By encouraging and motivating families across the country to explore the country's local, state, and national parks, children can learn about park stewardship, outdoor recreation, and the history of our nation. In preparation for Kids to Parks Day, which is hosted on the third Saturday of May annually, National Park Trust partners with cities and communities to invite children of all ages to visit their local and nearby parks. National Park Trust invites cities to cultivate future generations of outdoor enthusiasts and conservationists by participating in the 2019 Kids to Parks Day on May 18th of this year.

Homelessness Committee Meeting: The Committee would like to welcome Margaret Clark as the new incoming Vice Chair of the Homelessness Committee. Councilmember Clark was elected to the position at the December meeting. The Committee recognized Councilmember Joseph Lyons for his dedicated membership and inspiring leadership as committee chair over the past year. The Committee also acknowledged the enthusiastic, engaged participation of out-going member Cruz Baca of Baldwin Park.

In the 2018 City Implementation RFP, the County and United Way included a Regional Housing Trust Fund as an eligible component. Several cities expressed interest in participating in such a fund and included requests for funding in their proposals. Ms. Heather Stratman, Principle Strategic Advisors, presented upon Establishing a Regional Housing and Land Trust Fund. Ms. Stratman was instrumental in the creation of the Association of California Cities – Orange County's, Orange County Housing Finance Trust. One innovation in establishing this JPA, was the passage of AB 448 which, among other things, allows the OCHFT to solicit and utilize both government and nongovernmental funds. As the SGVCOG continues to explore developing a Regional Housing and Land Trust Fund, the model set forth in Orange County will provide clear guidance and lessons learned.

The Homelessness Committee encourages all cities, particularly those interested in a Housing Trust Fund, that have created homelessness plans, or submitted proposals under HEAP or the 2018 City Implementation RFP to consider designating representation on the Homelessness Committee. The Committee will focus our meetings to support the cities' homeless strategies. Cities interested in designating a representative may do so by e-mailing the SGVCOG Regional Homelessness Coordinator, jcicco@sgvcog.org. The leadership of an elected official is encouraged, but the City Council may designate a staff member in the event a Councilmember/Mayor cannot participate.

NOVEMBER MEETING RECAP

On Thursday, November 15th, 2018, the Transportation Committee convened its November meeting, which was the last meeting for this committee for calendar year 2018. There were three main agenda items for this meeting:

SGV Active Transportation Initiative: 5-City Plans and SGV Greenway Study Findings and

<u>Recommendations</u> – The first presentation on the agenda for the November meeting was given by Ryan Johnson, who is a Planning Associate with Alta Planning + Design, Inc. Alta Planning + Design is the firm which has been preparing the study for the San Gabriel Valley Greenway Network; work on a significant portion of this study has been developed over the last year and a half. During Mr. Johnson's presentation, he went over the methodology for scoring each of the greenway corridors in the SGV region. Additionally, he also provided overviews of the project corridors which were considered under this SGV Greenway Study, and described how the final version of the greenway report is structured. Additionally, Mr. Johnson provided information about the Active Transportation Plans for the cities of Glendora, Irwindale, La Puente, Monrovia, and Montebello. Both during and after Mr. Johnson's presentation, members of the Transportation Committee were able to provide comments and feedback on both the City Active Transportation Plans and the SGV Greenway Study.

LA Metro Mobility on Demand First/Last Mile Pilot Project – Emma Huang, who is a Principal Transportation Planner for LA Metro's Office of Extraordinary Innovation, provided the Transportation Committee with an overview presentation of this pilot project. Ms. Huang described how Metro is employing Via Transportation, Inc. to provide on-demand shared rides to and from select Metro stations. One of these three pilot stations will include the El Monte Bus Station. Only those who live or are commuting to and from a destination within the "catchment area" for the El Monte station will be eligible to utilize this pilot ride sharing service. The catchment area includes portions of El Monte, South El Monte, and Rosemead. Ms. Huang mentioned that the ride-sharing service will be in operation from 6:00 a.m. – 8:00 p.m., Monday through Friday, and that the base fare for a one-way ride will be \$1.75. The pilot program will launch in late-January 2019.

ExpressLanes Interfund Loan Principles and Policies – Shahrzad Amiri, who is the Executive Office of Congestion Reduction for LA Metro, provided the Transportation Committee with a presentation on the ExpressLanes Interfund Loan Principles and Policies. During this presentation, she and one other colleague discussed the rules, requirements, eligibility criteria, and guidelines for investing and expending interfund loans. Additionally, they also went through an examples loan repayment and cash flows schedule in great detail, too. Ms. Amiri also went over the purpose of these interfund loan policies, and how they can create increased capital for a plethora of projects in LA County.

MONTHLY REPORT

<u>Water Committee Meeting:</u> On November 13, the Water Policy Committee and Water TAC held their monthly meeting. The Committee and TAC recommended that the Governing Board support 2019 stormwater state legislative priorities. These priorities have the ultimate goal of assisting member agencies in complying with their MS4 stormwater permit requirements. Additionally, the Committee and TAC discussed and agreed on a list of workshop topics to present to the Los Angeles Regional Water Quality Control Board.

The Committee and TAC were also briefed on the November 6 election results on water related items. Proposition 3, a \$9 billion bond measure that would have modernized old dams, restored tainted watersheds and created desalination plants, among dozens of other water projects throughout the state failed by 48.3% to 51.7% Measure W, also known as the Safe, Clean Water Program successfully passed with more than 2/3 of the vote on the November 2018 ballot. The results were certified by the LA County Registrar and recorded on November 30, 2018.
