SGVCOG Governing Board Adopts 2020 Legislative Priorities

The SGVCOG annually adopts a legislative agenda to shape and guide advocacy efforts on regional issues of significance to San Gabriel Valley cities. The 2020 legislative platform builds on the accomplishments of the 2019 legislative agenda, seeks to accomplish unfinished objectives, and identify emerging issues in the core regional policy areas of water, energy, transportation, homelessness, and environment.

The platform aligns closely with the adopted SGVCOG Strategic Plan and ensures that advocacy is coordinated, effective, and responsive to legislative developments. On Thursday, January 16, 2020, the SGVCOG Governing Board unanimously voted to adopt the 2020 Legislative Priorities. Key summaries of each legislative priority can be found on the next page.

SGVCOG Governing Board Adopts 2020 Legislative Priorities (Cont.)

Transportation and Capital Projects



- Support and/or advocate for funding requests, grant applications, or specific budget earmarks to ensure projects are timely allocated or awarded state and county funds.
- Facilitate discussion of concepts that can improve transit operations, such as dedicated bus lanes, first/last-mile options, and route restructuring.
- Propose and advocate policies, funding, and programs beneficial to San Gabriel Valley transportation and capital projects and programs.

Homelessness



- Support legislation and funding that promotes solutions to homelessness for those facing mental health and/or substance abuse challenges.
- Support funding for the San Gabriel Valley Regional Housing Trust Fund and other entities that will create affordable housing for the region.
- Promote the allocation of Measure H resources towards cities' projects and programs that work to solve the homelessness crisis in the San Gabriel Valley.
- Support funding for prevention programs, including innovative local programs instituted by local cities.

Water



- Continue to advocate and/or pursue legislative solutions for adopting financial capability assessment guidelines in the issuance of MS4 permits that provide an economic analysis of the costs and benefits of water quality improvements.
- Continue to advocate for the establishment of reasonable timelines for compliance with new drinking water standards.
- Pursue legislative fixes that address the challenges that cities face in implementing SB 205 (Hertzberg), including updating the Standard Industrial Classification (SIC) codes.

Energy, Environment, and Natural Resources



- Support the creation of zero-waste policies and provide support for cities to reduce single-use plastics in the San Gabriel Valley.
- Support community choice aggregates (CCAs).
- Support the reduction of vehicle emissions through increased fuel efficiency, use of appropriate alternative fueled vehicles, and low-emission vehicles in public agency fleets.
- Support the diversification of solid waste management strategies, including conversion technology, that will create new markets and that are feasible given the landscape and conditions of the San Gabriel Valley.

San Gabriel Valley Cities Mobilize Volunteers for the 2020 Greater Los Angeles Homeless Count

The Los Angeles Homeless Services Authority (LAHSA) partners with cities to conduct a census of the homeless population through Los Angeles County every year. This census is commonly known as the Greater Los Angeles Homeless Count.

On the evening of Tuesday, January 21, 2020, over 1,000 volunteers spread out across the San Gabriel Valley to count the homeless population in the region. Volunteer deployment sites were set up in every community in the San Gabriel Valley. Los Angeles County Supervisors Hilda Solis and Kathryn Barger joined several city officials to participate in the Homeless Count in various volunteer deployment sites in San Gabriel Valley.

The annual homeless count takes place at night given that it is the time when individuals experiencing homelessness usually begin to settle in. Counting at night or in the early morning hours reduces the chance of double-counting an individual who has moved from one area to another.

The U.S. Department of Housing and Urban Development mandates that all Continuums of Care conduct a census of their homeless population during the last ten days of January. Historically the coldest month of the year, more individuals will be seeking refuge in shelters, which makes it easier for organizations to conduct the homeless count.

Data collected from the annual homeless count will be compiled and analyzed by the University of Southern California. It is expected that the data will be released in May or June 2020.


SGVCOG Welcomes New Staff Members
